## August 2018 monthly figures

### 1.809 million orders executed in the B2C business segment

Quickborn, 07 September 2018. In the B2C business segment (comdirect bank AG) 1.809 million orders were executed (July: 1.631 million). The number of customers in August stood at 2.422 million (July: 2.400 million). At the end of August, the number of custody accounts amounted to 1.319 million (July: 1.303 million). Assets under control in August amounted to €64.97bn (July: €64.42bn). Of this figure, €40.90bn is attributable to portfolio volume (July: €40.47bn) and €24.07bn to deposit volume (July: €23.95bn).

Note: On 10 July 2018, comdirect signed an agreement to sell its subsidiary ebase GmbH (B2B business segment). The transaction is still subject to the approval of banking supervisory and antitrust authorities. Efforts are being made to conclude the transaction before the end of 2018. With the sale, comdirect is focusing on its core business. As a result, the focus of the monthly figures is now on the B2C business.
