## May 2014 monthly figures

### 795,599 orders executed in the B2C business line

Quickborn, 6 June 2014. At the end of May, the total number of customers in the comdirect group stood at 2,823,649 (April: 2,818,793). The number of custody accounts amounted to 1,690,291 (April: 1,688,200) and total assets under custody totalled EUR 56.65bn in May (April: EUR 55.52bn).

In the B2C business line (comdirect bank) 795,599 orders were executed (April: 863,669). The number of customers in May stood at 1,838,016 (April: 1,832,111). At the end of May, the number of custody accounts amounted to 849,518 (April: 846,322). The number of current accounts rose to 1,075,820 (April: 1,067,032) and the number of Tagesgeld PLUS ("daily money PLUS") accounts climbed to 1,480,666 (April: 1,474,244). Assets under custody in May amounted to EUR 33.38bn (April: EUR 32.76bn). Of this figure, EUR 19.74bn is attributable to portfolio volume (April: EUR 19.33bn) and EUR 13.64bn to deposit volume (April: EUR 13.43bn).

In the B2B business line (ebase), the number of customers stood at 985,633 in May (April: 986,682). Assets under custody in May amounted to EUR 23.27bn (April: EUR 22.76bn).
