## October 2014 monthly figures

### 1,154,703 orders executed in the B2C business line

Quickborn, 7 November 2014. At the end of October, the total number of customers in the comdirect group stood at 2,858,798 (September: 2,849,746). The number of custody accounts amounted to 1,702,975 (September: 1,699,536) and total assets under custody totalled EUR 57.06bn in October (September: EUR 57.40bn).

In the B2C business line (comdirect bank) 1,154,703 orders were executed (September: 868,032). The number of customers in October stood at 1,876,565 (September: 1,867,181). At the end of October, the number of custody accounts amounted to 865,838 (September: 862,000). The number of current accounts rose to 1,122,189 (September: 1,111,667) and the number of Tagesgeld PLUS ("daily money PLUS") accounts climbed to 1,521,014 (September: 1,511,824). Assets under custody in October amounted to EUR 33.67bn (September: EUR 33.78bn). Of this figure, EUR 19.78bn is attributable to portfolio volume (September: EUR 19.98bn) and EUR 13.89bn to deposit volume (September: EUR 13.80bn).

In the B2B business line (ebase), the number of customers stood at 982,233 in October (September: 982,565). Assets under custody in October amounted to EUR 23.39bn (September: EUR 23.62bn).
