1.224 million orders executed in the B2C business line

Quickborn, 07 July 2017. At the end of June, the total number of customers in the comdirect group* stood at 3.155 million (May: 3.147 million). The number of custody accounts amounted to 1.902 million (May: 1.896 million) and total assets under custody totalled €81.47bn in June (May: €81.91bn).

In the B2C business line* (comdirect bank) 1.224 million orders were executed (May: 1.229 million). The number of customers in June stood at 2.114 million (May: 2.108 million). At the end of June, the number of custody accounts amounted to 1.037 million (May: 1.033 million). Assets under custody in June amounted to €50.15bn (May: €50.23bn). Of this figure, €30.30bn is attributable to portfolio volume (May: €30.62bn) and €19.85bn to deposit volume (May: €19.61bn).

In the B2B business line (ebase), the number of customers stood at 1.042 million in June (May: 1.039 million). Assets under custody in June amounted to €31.32bn (May: €31.68bn).
